1. Call to order.

- 2. Homeowners' issues and concerns.
 - a) Rafter J Ranch Partnership (Lot 332): horses on 3.1 acres.

Too Buds, LLC has an option to purchase lot 332 and has been working with Strout Architects to design 16 fenced paddocks, horse stalls, one manager unit apartment, a hot-walk area, a covered arena, hay storage areas, and covered areas for trailers. The perimeter of the lot will be fenced.

The Board noted that in the present design, the north and south entrances would require easements. The covered arena doesn't appear to have the required 20 ft setback from the road. The final design would have to be approved by the Rafter J Design Review Committee.

b) Maintenance of Rafter J homes/yards

The Board has been contacted by a homeowner who is concerned with unauthorized gravel driveways and poor maintenance of Rafter J properties. The Board will send out letters to non-compliant homeowners. The letters will be copied to Jennifer Anderson, County Code Compliance Officer.
